Applications in the prescribed format is invited for preparation of a panel of candidates for the posts of Non P.G. Junior Residents (Dental) for fixed tenure of **one year** only, in the **pay level-10 (Rs. 56,100 – 1,77,500 + NPA and other allowances as admissible)**. The Candidates from this panel may also be offered JR-ship in other Delhi Govt. Hospitals, if so required. The candidates kept on panel will be offered appointment against the

vacant posts as and when the post of a particular category falls vacant. The Panel shall be valid for a period of 12 months from the date of declaration of final result, or when the next recruitment is carried out, whichever is earlier.

The educational qualification, age etc. as stipulated in advertisement shall be determined as on the closing date of submission i.e. on 21/07/2025.

Candidates who wish to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificate (EWS/SC/ST/OBC (Non Creamy Layer)/PwD etc.) issued by the Competent Authority on or before the closing date of application, otherwise their claim for reservation in the category will not be entertained.

The <u>OBC certificate should be issued from Govt. of NCT of Delhi as "OBC (Delhi)".</u> OBC Certificate issued from other than this will be considered under General category. General Candidates are not eligible to apply against Reserve category post.

#### 1. AGE LIMIT

Below 30 years as on last date of submission of application. Relaxation in age will be allowed as per rules.

#### 2. **ELIGIBILITY**

- i) Passed BDS from a recognized University including internship not before 21/07/2023.
- ii) Applicants having post graduate qualification are not eligible.
- The period for which a candidate has already worked in any Govt. Hospital as Junior Resident (Dental) will be deducted from the maximum period of one year of Junior Residency. Those who have already worked for a period of one year in any Govt. hospitals are not eligible.
- iv) All the candidates who applied with prescribed fee for the post of Junior Resident (Dental) 2025 will be allowed to appear in the screening test subject to the conditions that the eligibility criteria shall be checked only in respect of the eligible candidates who qualify the written test. In case the candidate fails to fulfill the criteria after qualifying the screening test he/she shall not be eligible for interview and no correspondence or representation shall be entertained under any circumstances.

## 3. FEE PAYABLE

Rs. 1000/- for GEN & OBC candidates, and Rs. 500/- for SC/ST/EWS candidates. The fee should be paid in the form of Demand Draft in favour of "Director-Principal, MAIDS", <u>Payable at New Delhi.</u> Fee is not refundable in any case. PwD candidates shall be exempted from examination/application fee.

## 4. MODE OF SELECTION

The selection will be made through screening test followed by interview of shortlisted candidates. As per merit Candidates three times the number of vacancies in each category will be called for interview, those candidates who meet the eligibility criteria in scrutiny for the specific post including age, educational qualifications and other requirements, and provided they qualify the screening test with a minimum of 50% marks in Gen category, 45% marks for OBC category and 40% marks for SC/ST/EWS/PwD category. Qualifying written test does not confer selection. Candidates called for interview will be formally evaluated on the basis of their performance both in screening test and interview.

### 5. HOW TO APPLY

Complete application in the prescribed format alongwith the documents and fee must reach on or before 21/07/2025 upto 2:00 PM directly or by post, addressed to "The Director-Principal, Room No. 501, Fifth Floor, Phase – II Building, Maulana Azad Institute of Dental Sciences, Bahadur Shah Zafar Marg, New Delhi-110002. The application form is available on the website <a href="https://www.maids.delhi.gov.in">www.maids.delhi.gov.in</a>. The applicants must fill in the prescribed form only available on the website. The Institute will not be responsible for any postal delay or delay on the part of any delivery agency.
